I. TRANSPORTATION TO NON-PUBLIC SCHOOLS

The deadline for filing applications for transportation to a non-public school for the 2020-2021 school year is **April 1, 2020**. It is necessary to submit a **new** application for **each** child **each year**. All applications received after the deadline must have a letter attached explaining why it is being submitted after April 1st. New residents have 30 days to file this request. Late applications are subject to school board approval before transportation can be arranged. Wayne Central will not provide transportation to any Non-Public school when Wayne Central School District is closed (Holiday Recess, Superintendent's Conference Days, Staff Development Days, Emergency Closing Day etc.).

An application must be submitted even if no transportation will be required.

II. ATTENDANCE AT NON-PUBLIC SCHOOLS NOT SERVED BY WAYNE CENTRAL TRANSPORTATION DEPARTMENT

Our district also purchases textbooks and pays for health services for resident students enrolled at non-public schools, which request them. If your child will be attending a non-public school, which is not within the transportation mileage limits, we ask that you complete an application form to keep our textbook and attendance records accurate. If your child will be attending a non-public school that is **not** served by our transportation department, please complete the form and place a check mark in the "**attendance notice**" space on the application form.
